UBS Asset Management is pleased to provide you with this interim holdings report for Master Trust—Prime Series II Master Fund (the "Master Fund"). Each of the funds in the UBS Select Prime Series II is a "feeder fund" that invests in individual money market securities through the Master Fund. Holdings are as of February 16, 2024. The UBS Select Prime Series II feeder funds are UBS Select Prime Series II Preferred Fund and UBS Select Prime Series II Institutional Fund.
