In observance of the Good Friday holiday in the United States, all of the UBS Money Market Funds will be closed on Friday, April 19.

Additionally, on Thursday April 18, the following UBS Money Market Funds will close early:

- UBS Tax-Free Funds will close at 12:00 p.m. (noon) (ET).
- UBS Select Prime Funds, UBS Select Treasury Funds, UBS Select Government Funds and UBS Prime CNAV Funds will close at 3:00 p.m. (ET).
